# Homeless Persons' Legal Clinic (HPLC)

- Bankruptcy

If you require criminal or family law assistance, HPLC will do its best to refer you to another legal service provider.

HPLC provides legal services at crisis accommodation centres and welfare agencies, including Melbourne Citymission, The Big Issue, St Vincent de Paul Society, the Salvation Army, Anglicare, Urban Seed, Hanover and Arqyle Housing Service.

# How to get legal assistance?

The Public Interest Law Clearing House (PILCH) is a non-profit, independent legal referral service which coordinates the provision of pro bono (without fee) legal assistance.

PILCH provides its services through four pro bono legal assistance schemes, which operate from the PILCH office and form a 'one stop pro bono shop'.

PILCH administers the following Schemes:

- The Public Interest Law Scheme
- The Victorian Bar Legal Assistance Scheme (VB LAS)
- The Law Institute of Victoria Legal Assistance Scheme (LIV LAS)
- The Homeless Persons' Legal Clinic (HPLC)

The Public Interest Law Scheme, VB LAS and LIV LAS receive and assess requests for pro bono legal assistance and then refer successful applicants to the private legal profession, where there are available pro bono resources. HPLC provides legal services at crisis accommodation centres and welfare agencies so as to encourage direct access by clients. Services for HPLC are provided by pro bono lawyers from participating law firms and corporate legal departments.

# Which scheme is right for you?

## Public Interest Law Scheme

#### Do you meet all of these criteria?

- Your matter has legal merit
- · You are ineligible for legal aid
- You meet a means test
- · Your matter is in the 'public interest'

The public interest requirement means:

- The legal matter is for a non-profit organisation with public interest objectives, or
- The legal matter is for an individual, where that matter raises an issue which requires addressing for the public good and:
  - affects a significant number of people (not just the individual),
- is of broad concern, or
- impacts on disadvantaged or marginalised groups.

If your matter meets these criteria, PILCH may be able to refer your matter to a solicitor and/or a barrister who will provide legal assistance for free.

## Victorian Bar Legal Assistance Scheme (VB LAS)

#### Do you meet all of these criteria?

- Your matter has legal merit
- You are ineligible for legal aid
- · You meet a means test
- · The provision of assistance is in the 'interests of the administration of justice'

If your matter meets these criteria, VB LAS may be able to refer your matter to a barrister who will provide legal assistance for free.

Assistance which can be sought from VB LAS includes the provision of legal advice, the drawing up or settling of court documents, representation before a court or tribunal, or any other assistance which a barrister is ethically permitted to provide.
